

Terms and Conditions for “Zero Commission” Promotion

1. The “Zero Commission” promotion (“Promotion”) runs from 1 March 2015 to 31 August 2015, both dates inclusive (“Qualifying Period”).
2. This Promotion is open to existing clients of Maybank Kim Eng Securities Pte Ltd (“Maybank KES”) with a KE Trade Prefunded account (“Client”) and every new client (“New Client”) who opens a KE Trade Prefunded account during the Qualifying Period.
3. The following persons are not eligible to participate in this promotion:
 - Maybank KES institutional clients and corporate clients
 - Maybank KES account holders whose accounts have been suspended, cancelled or terminated
4. Maybank KES account holders whose accounts have been suspended, cancelled or terminated
